

SCHEDULE 1

INTERSTATE COMMERCE COMMISSION

IC Leasing Corporation II ("ICL") hereby leases the following locomotives to Illinois Central Railroad ("Lessee") pursuant to that certain Railroad Locomotive Lease Agreement dated as of January 14, 1993 between ICL and Lessee (the "Master Lease"). This Schedule is executed pursuant to the terms of the Master Lease and is hereby made a part hereof. The terms of the Master Lease, except to the extent inconsistent herewith, are incorporated herein by reference.

- (1) Number of Units: Seventeen (17)
- (2) Description: EMD SD40-2 locomotives
- (3) Unit Marks and Numbers: BN 6753-6759, 6761-6764, 6766, 6768-6772 (before acquisition); IC 6144 - 6160 (after acquisition)
- (4) Delivery Point: As mutually agreed by ICL and Lessee
- (5) Interim Lease Term: Period commencing with the Acceptance Date as to each Unit and ending on February 28, 1993.
- (6) Per Unit Interim Rental: Rent shall be paid at the rate of \$250 per day for each Unit subject to the Master Lease for the number of days elapsed (if any) during the Interim Lease Term, with such rent to be payable in arrears on the first day of the month following each month in which days occur for which such rent is due.
- (7) Interim Casualty Value of Units: The casualty value per unit during the Interim Lease Term shall be \$262,000 per unit.




