



AMENDMENT TO  
LEASE AGREEMENT

INTERSTATE COMMERCE COMMISSION

This Amendment to the Lease Agreement (the "Amendment"), is entered into this 18th day of March, 1994, by and between The David J. Joseph Company, a Delaware corporation (hereinafter referred to as "Lessor") and Peoria and Pekin Union Railway, an Illinois corporation (hereinafter referred to as "Lessee") amending that certain Lease Agreement (the "Lease") dated September 25, 1992, by and between Lessor and Lessee.

WHEREAS, the Lease was duly filed for recordation with the Interstate Commerce Commission ("ICC") on January 4, 1993, with recordation number 18086.

WHEREAS, the parties desire to amend the Lease by deleting from the Lease, the twenty-five (25) railcars bearing reporting marks PPU 2070-2094, inclusive (the "Cars"), which are currently subject to the Lease, and adding a replacement set of twenty-three (23) Cars as identified in Exhibit A attached hereto.

WHEREAS, the parties further desire to amend the Lease to extend the Lease Expiration Date to [REDACTED], for all Cars subject to the Lease.

WHEREAS, the parties further desire to amend the Lease to decrease the fixed rental rate from [REDACTED] per Car, per day to [REDACTED] per Car, per day.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

The Lease is amended by deleting Exhibit A to the Lease in its entirety and replacing it with Exhibit A attached hereto. The Lease is further amended by extending the Lease expiration date to [REDACTED], for all Cars subject to this Lease. The Lease is further amended by decreasing the fixed rental rate from [REDACTED] per Car, per day to [REDACTED] per Car, per day. All other terms and conditions of the Lease remain unchanged and in full force and effect.
