

**MEMORANDUM OF MORTGAGE SUPPLEMENT NO. 1  
(SANTA FE TRUST NO. 1996-1)**

Memorandum of Mortgage Supplement No. 1, made and entered into on February 22, 1996 by and between First Security Bank of Utah, National Association, a national banking association, as security trustee ("*Security Trustee*"), and Dia Brook Ltd., a Japanese corporation ("*Borrower*").




