

MEMORANDUM OF PARTIAL ASSIGNMENT AGREEMENT

Amendment No. 2 to Schedule No. 1 to that certain Lease Agreement dated as of November 18, 1992 by and between Greenbrier Leasing Corporation, as lessor, and The Atchison Topeka and Santa Fe Railway Company, as lessee, but only to the extent of one Maxi-Stack® III five-unit articulated double stack railcar marked and numbered SFLC 254379. (A1-10)
2. Rider No. 2 to that certain Lease Agreement dated as of March 2, 1992 by and between Greenbrier Leasing Corporation, as lessor, and Burlington Northern Railway Company, as lessee, but only to the extent of three five-unit double stack railcars covered by Rider No. 2 marked and numbered BN 63965 through BN 63967, inclusive. (B1-10)
3. Rider No. 3A to that certain Lease Agreement dated as of March 2, 1992 by and between Greenbrier Leasing Corporation, as lessor, and Burlington Northern Railway Company, as lessee, but only to the extent of two Husky-Stack single-unit double stack railcars covered by Rider No. 3A marked and numbered BN 61899 and BN 61900. (B1-14)
4. Rider No. 6 to that certain Lease Agreement dated as of March 2, 1992 by and between Greenbrier Leasing Corporation, as lessor, and Burlington Northern Railway Company, as lessee, but only to the extent of twenty Maxi-Stack I single-unit double stack railcars covered by Rider No. 6 marked and numbered BN 64980 and BN 64999. (B1-15)
5. Rider No. 7 to that certain Lease Agreement dated as of March 2, 1992 by and between Greenbrier Leasing Corporation, as lessor, and Burlington Northern Railway Company, as lessee, but only to the extent of one all purpose Husky-Stack single-unit double stack railcar covered by Rider No. 7 marked and numbered BN 61010. (B1-17)
6. Equipment Lease Agreement dated as of March 29, 1995 by and between Greenbrier Leasing Corporation, as lessor, and Wisconsin Central Ltd., as lessee, but only to the extent of five five-unit double stack railcars covered by such agreement marked and numbered WC 36604 and WC 36607 through WC 36610, inclusive. (W4-9)
7. Lease Agreement dated as of June 15, 1988 by and between Greenbrier Leasing Corporation, as lessor, and Southern Pacific Transportation Company, as lessee, but only to the extent of one five-unit double stack railcar covered by such agreement marked and numbered SP 2101. (S1-1)

8. Lease Agreement dated as of March 20, 1989 by and between Greenbrier Leasing Corporation, as lessor, and Southern Pacific Transportation Company, as lessee, but only to the extent of ten five-unit double stack railcars covered by such agreement marked and numbered SP 2397 and SP 2398 and SP 2401 through SP 2404 inclusive, and SP 2411 through SP 2414, inclusive. (S1-11)
