MEMORANDUM OF ASSIGNMENT
OF SCHEDULE NO. 1, SCHEDULE NO. 2 AND SCHEDULE NO. 3 TO
LEASE AGREEMENT

THIS MEMORANDUM OF ASSIGNMENT OF SCHEDULE NO. 1, SCHEDULE NO. 2 AND SCHEDULE NO. 3 TO LEASE AGREEMENT (this "Memorandum") is made as of June 29, 1999 by FMB BANK (formerly known as The First National Bank of Maryland), a Maryland banking corporation (the "Assignor"), and ICX CORPORATION, an Ohio corporation (the "Assignee").

A. The Assignor and the Assignee are parties to that certain Transfer Agreement (the "Transfer Agreement") dated as of June 29, 1999 pursuant to which the Assignor assigned to the Assignee and the Assignee purchased from the Assignor all of the Assignor's right, title and interest in and to Schedule No. 1 dated February 1, 1992, Schedule No. 2 dated January 6, 1994 and Schedule No. 3 dated January 9, 1994, each issued pursuant to the Lease Agreement dated February 1, 1992 (collectively, the "Lease") between Assignor, as successor lessor, and Union Pacific Railroad Company, as successor lessee ("Lessee").

B. Pursuant to the Lease, Assignor has leased to Lessee certain railcars as described on Exhibit A attached hereto and made a part hereof.

C. A Memorandum of the Lease Agreement, and Schedule No. 1 thereto, both dated February 1, 1992, was recorded with the Interstate Commerce Commission (the "Commission") on September 25, 1992, under Recordation No. 17946.




