
RELEASE OF EQUIPMENT INTERSTATE COMMERCE COMMISSION

The undersigned, La Salle National Bank (the "Agent"), as assignee under (1) that certain Assignment of Lease and Agreement dated as of March 15, 1985 with State Street Bank and Trust Company of Connecticut, National Association (successor in interest to The Connecticut Bank and Trust Company, National Association), not in its individual capacity but solely as Trustee ("Trustee") under a Trust Agreement dated as of March 15, 1985 with Pacific Harbor Capital, Inc. (formerly known as PacifiCorp Finance, Inc.)
