TERMINATION OF AGREEMENTS NO. 1

THIS TERMINATION OF AGREEMENTS NO. 1, made this 7th day of June, 1994, by and among State Street Bank and Trust Company (successor to The Connecticut Bank and Trust Company as trustee; "Trustee"), Mellon Bank (East) N.A. (successor to Girard Bank as security trustee; "Security Trustee") and Burlington Northern Railroad Company, a Delaware corporation ("BNRC").

WHEREAS, Trustee and BNRC are parties to that certain Equipment Lease, dated as of January 15, 1979 (as it may have been supplemented and amended, the "Lease") and Trustee and Security Trustee are parties to that certain Security Agreement-Trust Deed, dated as of January 15, 1979 (as it may have been supplemented and amended, the "Security Agreement") (the Lease and the Security Agreement together, the "Agreements"); and

WHEREAS, the Agreements were duly filed for recordation with the Interstate Commerce Commission (the "ICC") pursuant to 49 U.S.C. Section 11303, on March 12, 1979, at 9:30 a.m. and given Recordation Numbers 10184 and 10185, respectively; and

WHEREAS, Trustee, Security Trustee and BNRC desire to terminate and cancel each of the Agreements with respect to the equipment described therein and to record such termination and cancellation with the ICC;

NOW THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt of which is acknowledged, Trustee, Security Trustee and BNRC, intending to be legally bound, agree as follows.

1. Trustee and BNRC hereby terminate and cancel the Lease, and Trustee and Security Trustee hereby terminate and cancel the Security Agreement effective June 7, 1994, with respect to all the equipment described in each such agreement (hereinafter, the "Terminated Equipment"), and Trustee, Security Trustee and BNRC hereby agree that no rights, duties or liabilities under either of the Agreements with respect to such Terminated Equipment shall survive the termination and cancellation of the Agreements, except with respect to acts, events, or omissions occurring on or prior to the date hereof.

2. The parties agree to record this Termination of Agreements No. 1 with the ICC so as to release any lien against the Terminated Equipment created by or arising out of either of the Agreements.

3. This Termination of Agreements No. 1 may be executed in any number of counterparts, each executed counterpart

constituting an original but all together only one Termination of Agreements No. 1.




