



AGREEMENT RELEASING SECURITY  
IN CERTAIN LOCOMOTIVES

This agreement releasing security (Agreement), dated as of June 1, 1991, between HELM LOCOMOTIVE LEASING, a joint venture (the Company) of Helm Equipment Leasing, Corporation and Domestic Three Corporation, and NATIONAL BANK OF DETROIT (the Bank).

The Company and the Bank wish to release certain locomotives as Collateral from a security agreement (Security Agreement), dated as of July 14, 1987, given by the Company in favor of the Bank.

Now therefore, pursuant to the terms of the Security Agreement and the Credit Agreement (as defined in the Security Agreement) and for good and valuable consideration granted by each party to the other, the parties agree as follows:

Delete from the Collateral (as defined in the security granting clause of the Security Agreement) nine (9) GP 38-2 locomotives bearing the reporting marks MP 2018, 2019, 2021, 2022, 2025, 2037, 2039, 2045 and 2052.
