NOTICE OF TERMINATION OF LEASE AND MEMORANDUM OF LEASE INTERSTATE COMMERCE COMMISSION

THIS NOTICE OF TERMINATION OF LEASE AND MEMORANDUM OF LEASE is made as of this 14 day of July, 1995, by and between GENERAL ELECTRIC RAILCAR LEASING SERVICES CORPORATION, whose mailing address is 33 West Monroe Street, Chicago, IL 60661 ("GE" or "Lessor") and PADUCAH & LOUISVILLE RAILWAY, INC., whose mailing address is 1500 Kentucky Avenue, Paducah, KY 42003 ("P&L" or "Lessee").

WITNESSETH:

WHEREAS, P&L entered into a Lease Agreement on August 1, 1986, with NRUC Transportation Division, a South Carolina corporation ("NRUC"), as Lessor and P&L as Lessee therein, recorded August 13, 1987, under Recordation No. 15287, covering two hundred (200) box cars, PAL 701100-701299 (the "NRUC Lease"); and

WHEREAS, GE acquired ownership of the above described railcars from NRUC subject to the NRUC Lease; and

WHEREAS, the NRUC Lease has been terminated; and

WHEREAS, a portion of the above described railcars, more particularly described on Exhibit "A", attached hereto, are under lease from GE, as Lessor, to P&L, as Lessee, pursuant to a Lease Agreement, dated August 1, 1991;

NOW, THEREFORE, the parties desiring to clarify the public record state as follows:

- 1. This Memorandum shall serve as notice that the term of the NRUC Lease has expired, was not further extended and is considered terminated in all respects.
2. GE, as Lessor, and P&L, as Lessee, have entered into a Lease Agreement, dated August 1, 1991, pertaining to the railcars which are described on Exhibit "A", attached hereto (the "GE Lease").
3. The execution and delivery of this Memorandum is not intended to and shall not change, modify, amend or enlarge the provisions of the GE Lease. The parties agree that this Memorandum shall be recorded at the Interstate Commerce Commission.
