

**MEMORANDUM OF FULL TERMINATION

THIS MEMORANDUM OF FULL TERMINATION OF LEASE OF RAILROAD EQUIPMENT is made as of this 26th day of October, 1999 by General Electric Capital Corporation (formerly known as General Electric Credit Corporation) ("GECC").

WHEREAS, by that certain Lease of Railroad Equipment dated as of October 15, 1975 (the "Lease") between American Rail Box Car Company ("Lessee") and United States Trust Company of New York ("US Trust") as Owner Trustee ("Lessor"), under a Trust Agreement dated as of October 15, 1975 between GECC as Owner and US Trust as Owner Trustee, Lessor leased certain railcars to Lessee.


WHEREAS, the Lease was recorded with the Interstate Commerce Commission (now the Surface Transportation Board) on November 7, 1975 under recordation number 8111.
