

INSTRUMENT OF SATISFACTION AND RELEASE dated as of March 1, 1991 by and among MERCANTILE-SAFE DEPOSIT AND TRUST COMPANY, as Agent (the "Agent"), UNITED STATES TRUST COMPANY OF NEW YORK, as Trustee (the "Trustee") under a Trust Agreement dated as of December 1, 1975, with General Electric Capital Corporation (formerly known as General Electric Credit Corporation), and the SOUTHERN PACIFIC TRANSPORTATION COMPANY, the successor in interest to American Rail Box Car Company, as Lessee (the "Lessee").

## WITNESSETH:

WHEREAS, ACF INDUSTRIES, INCORPORATED, the Trustee and the Lessee, hereto entered into a Conditional Sale Agreement (the "ACF INDUSTRIES Conditional Sale Agreement") dated as of December 1, 1975;

WHEREAS, the ACF INDUSTRIES Conditional Sale Agreement was filed and recorded with the Interstate Commerce Commission on December 30, 1975, and assigned Recordation No. 8165;

WHEREAS, ACF INDUSTRIES, INCORPORATED and the Agent entered into an Agreement and Assignment (the "ACF INDUSTRIES Assignment"), dated as of December 1, 1975;

WHEREAS, ACF INDUSTRIES, INCORPORATED Assignment was filed and recorded with the Interstate Commerce Commission on December 30, 1975, and assigned Recordation No. 8165-A;

WHEREAS, FMC CORPORATION, the Trustee and the Lessee hereto entered into a Conditional Sale Agreement (the "FMC CORPORATION Conditional Sale Agreement") dated as of December 1, 1975;

WHEREAS, the FMC CORPORATION Conditional Sale Agreement was filed and recorded with the Interstate Commerce Commission on December 30, 1975, and assigned Recordation No. 8166;

WHEREAS, FMC CORPORATION and the Agent entered into an Agreement and Assignment (the "FMC Assignment"), dated as of December 1, 1975;

WHEREAS, the FMC CORPORATION Assignment was filed and recorded with the Interstate Commerce Commission on December 30, 1975, and assigned Recordation No. 8166-A;

WHEREAS, WHITTAKER CORPORATION (Berwick Forge and Fabricating Division), the Trustee and the Lessee hereto entered into a Conditional Sale Agreement (the "WHITTAKER Conditional Sale Agreement") dated as of December 1, 1975;

WHEREAS, the WHITTAKER Conditional Sale Agreement was filed and recorded with the Interstate Commerce Commission on January 6, 1976, and assigned Recordation No. 8172;

WHEREAS, WHITTAKER and the Agent entered into an Agreement and Assignment (the "WHITTAKER Assignment"), dated as of December 1, 1975;

WHEREAS, the WHITTAKER Assignment was filed and recorded with the Interstate Commerce Commission on January 6, 1976, and assigned Recordation No. 8172-A;

WHEREAS, the Trustee and American Rail Box Car Company ("Rail Box") entered into a Lease of Railroad Equipment (the "Old Lease"), dated as of December 1, 1975, covering the equipment described in Schedule A thereto;

WHEREAS, the Old Lease was filed and recorded with the Interstate Commerce Commission on December 30, 1975, and assigned Recordation No. 8167;

WHEREAS, the Trustee and Agent entered into an Assignment of Lease and Agreement (the "Old" Lease Assignment"), dated as of December 1, 1975, with respect to the Old Lease;

WHEREAS, the Old Lease Assignment was filed and recorded with the Interstate Commerce Commission on December 30, 1975, and assigned Recordation No. 8167-A;

WHEREAS, Rail Box failed to make certain payments due under the Old Lease and assigned its interests thereunder to the Lessee, as Guarantor, whereupon the Lessee and the Trustee entered into a new Lease of Railroad Equipment dated as of March 1, 1983 (the "New Lease"), and the New Lease was filed and recorded with the Interstate Commerce Commission on January 17, 1984, and assigned Recordation No. 14255;

WHEREAS, the Trustee and the Agent entered into an Assignment of Lease and Agreement (the "New Lease Assignment"), dated as of March 1, 1983, with respect to the New Lease;

WHEREAS, the New Lease Assignment was filed and recorded with the Interstate Commerce Commission on January 23, 1984, and assigned Recordation Nos. 14255-A, 8165-B, 8166-B, 8167-C and 8172-B;

WHEREAS, the parties hereto desire to execute this Instrument to evidence for public records the satisfaction and release of the rights and obligations of the parties under the ACF INDUSTRIES, INCORPORATED Conditional Sale Agreement, the FMC CORPORATION Conditional Sale Agreement, the WHITTAKER Conditional Sale Agreement, the ACF INDUSTRIES Assignment, the FMC CORPORATION Assignment, the WHITTAKER Assignment, the Old Lease Assignment and the New Lease Assignment;

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency whereof is hereby acknowledged, the parties hereto do hereby acknowledge the satisfaction and release of all the covenants, obligations, liens, and warranties of the ACF INDUSTRIES Conditional Sale Agreement, the FMC CORPORATION Conditional Sale Agreement, the WHITTAKER Conditional Sale Agreement, the ACF INDUSTRIES Assignment, the FMC CORPORATION Assignment, the WHITTAKER Assignment, the Old Lease Assignment ; and the New Lease Assignment;

The Trustee will cause this Instrument to be filed and recorded with the Interstate Commerce Commission pursuant to 49 U.S.C. Section 11303, and will furnish a recorded counterpart thereof to the Agent.

This Instrument shall be executed in several counterparts, each of which when so executed shall be deemed to be an original and such counterparts together shall constitute but one and the same instrument.

IN WITNESS WHEREOF, the Agent, the Trustee, and the Lessee have caused this Instrument to be signed in their respective corporate names and their respective corporate seals to be hereunto affixed and attested by their respective duly authorized officers as of the day and year first above written.


