Memorandum of a Lease Agreement made and entered into as of September 25, 1995, with Rider No. 7 dated as of September 25, 1995, by and between Greenbrier Leasing Corporation, a Delaware corporation, ("Lessee") and First Union Rail Corporation, a North Carolina corporation ("Lessor").
