



This Amendment No. 3 to MASTER EQUIPMENT SUBLEASE (the "Amendment" is entered into as of the 16 day of March, 1998, between Illinois Central Railroad Company, an Illinois corporation ("Lessor"), and Progress Rail Services Corporation, an Alabama corporation ("Lessee").




