



TERMINATION OF LEASE

THIS TERMINATION OF LEASE OF RAILROAD EQUIPMENT ("Termination") is made as of February 5, 1996 by HELM FINANCIAL CORPORATION, a California corporation ("Lessor").

1. **Recitals.** Lessor entered into the Lease of Railroad Equipment dated as of September 1, 1989 (the "Lease") with INDIANA HI-RAIL CORPORATION, an Indiana corporation, with respect to the ten (10) railcars described in Schedule A attached hereto (the "Units"). 
