

**THIRD NOTICE OF RENUMBERING
OF LEASED LOCOMOTIVE UNITS**

WHEREAS Chase Manhattan Service Corporation (predecessor-in-interest to **Mellon Leasing Corporation**) as lender and **Meridian Trust Company** (predecessor-in-interest to **First Union National Bank**) as owner-trustee ("First Union") entered into a Loan and Security Agreement dated as of June 1, 1990 (the "L&SA"), as amended and bifurcated with respect to the locomotive interests, (the "Locomotive L&SA") covering 20 locomotives,

WHEREAS Grand Trunk Western Railroad Company (predecessor-in-interest to **Grand Trunk Western Railroad Incorporated**) as lessee (the "Lessee") entered into a Lease of Railroad Equipment dated as of June 1, 1990 (the "Lease"), as amended and bifurcated with respect to the locomotive interests, (the "Locomotive Lease"), with First Union as lessor (and owner-trustee under a Trust Agreement, as amended and bifurcated with respect to the locomotive interests, of even date with Chase Commercial Corporation (predecessor-in-interest to **Comerica Bank**) as owner), covering the 20 locomotives subject to the Locomotive L&SA,

WHEREAS the L&SA and the Lease were recorded with


- 1) The Interstate Commerce Commission (predecessor to the Surface Transportation Board), in accordance with 49 U.S.C. Section 11303 (now Section 11301), on June 27, 1990 at 9.45 AM and assigned recordation numbers 16904 and 16905, respectively, and
- 2) The Office of the Registrar General of Canada, pursuant to Section 90 of the Railway Act of Canada (now Section 105 of the Canada Transportation Act), on June 27, 1990 at 9 08 AM

NOW THEREFORE, TAKE NOTICE THAT a) pursuant to the terms of the Locomotive L&SA and the Locomotive Lease, the Lessee has renumbered certain of the locomotives subject to the Locomotive L&SA and the Locomotive Lease, as set forth on Schedule A attached hereto and made a part hereof, and b) the Lessee shall cause this Third Notice of Renumbering to be filed at x) the Surface Transportation Board and y) the Office of the Registrar General of Canada
