

THIS TERMINATION OF LEASE OF RAILROAD EQUIPMENT is made as of September 20, 1993 by HELM LOCOMOTIVE LEASING, a joint venture of Domestic Three Leasing Corporation and Helm Equipment Leasing Corporation ("Helm").


1. Recitals: Helm entered into the Lease of Railroad Equipment dated as of April 13, 1990, as amended (the "Lease"), with Grand Trunk Western Railroad Incorporated, as successor by name change to Grand Trunk Western Railroad Company, with respect to certain locomotives described in Exhibit A attached hereto (the "Units"). 
