



### SHORT FORM OF HEAD LEASE

This Short Form of Head Lease is made and dated as of the 18<sup>th</sup> day of December, 1998, by and among, **WASHINGTON METROPOLITAN AREA TRANSIT AUTHORITY**, a body corporate and politic created and existing under and by virtue of a compact between the State of Maryland, the Commonwealth of Virginia and the District of Columbia and having an address at 600 Fifth Street, NW, Washington, D.C. 20001 ("**Head Lessor**") and **WMATA 1998 TRUST SSBTC A** ("**Head Lessee**"), a Delaware statutory business trust, having an address in care of Wilmington Trust Company, 1100 North Market Street, Wilmington, Delaware 19890-0001:

**A.** Head Lessor is the owner of that certain Equipment described in Exhibit A attached hereto and incorporated herein by reference (the "**Equipment**").

**B.** Head Lessor desires to lease the Equipment to Head Lessee, and Head Lessee desires to lease the Equipment from the Head Lessor on the terms and conditions set forth in that certain Head Lease Agreement between Head Lessor and Head Lessee, of date even herewith (the "**Head Lease**"), which by this reference is incorporated herein and made a part hereof as if set forth at length.

**C.** Head Lessor and Head Lessee desire to record this Short Form of Head Lease with the U.S. Surface Transportation Board to give constructive notice of Head Lessee's leasehold interest in the Equipment.

**D.** Attached hereto as Exhibit B is a Head Lease Certificate of Acceptance between Head Lessor and Head Lessee of even date herewith, which is incorporated herein by reference and made a part hereof as if set forth at length.

In consideration of the foregoing recitals, and for other good and allowable consideration, the receipt and sufficiency of which are hereby acknowledged, Head Lessor and Head Lessee agree as follows:

**1. Property Leased.** Head Lessor hereby leases to Head Lessee, and Head Lessee hereby leases from Head Lessor, the Equipment for the term, and on the covenants and conditions set forth in the Head Lease, which Head Lease is by this reference incorporated herein and made a part hereof as if set forth herein at length.

**2. Term of Head Lease.** The above-described lease term is for the term set forth in the Head Lease, subject to any extension or renewal options contained in the Head Lease.



HEAD LEASE CERTIFICATE OF ACCEPTANCE (WMATA-SSBTC-A), dated December \_\_, 1998, by WASHINGTON METROPOLITAN AREA TRANSIT AUTHORITY, a body corporate and politic established under the Compact (herein called the "Head Lessor"), and by WMATA 1998 TRUST SSBTC A, (herein called the "Head Lessee"). WITNESSETH:

WHEREAS, the Head Lessor and the Head Lessee, concurrently herewith, are entering into the Head Lease Agreement (the "Head Lease"). The Participation Agreement provides for, inter alia, the execution and delivery on the date hereof of this Head Lease Certificate of Acceptance for the purpose of acknowledging delivery of specific Items of Equipment under the Head Lease and leasing such Items of Equipment under the Head Lease as and when delivered in accordance with the terms thereof.

NOW, THEREFORE, in consideration of the premises and other good and sufficient consideration, the Head Lessor and the Head Lessee hereby agree as follows:

1. The Head Lessor hereby delivers and leases to the Head Lessee under the Head Lease, and the Head Lessee hereby accepts and leases from the Head Lessor under the Head Lease, the Items of Equipment specified in Schedule I hereto.
2. The date of delivery and acceptance of such Items of Equipment under the Head Lease is the date of this Head Lease Certificate of Acceptance as set forth in the opening paragraph hereof, on which date the Term for such Items of Equipment shall commence.
3. The Head Lessee hereby confirms to the Head Lessor that the Head Lessee has accepted such Items of Equipment for all purposes of the Head Lease as being in good working order and repair and without defect or inherent vice in condition, design, operation or fitness for use, and otherwise in full compliance with the Head Lease.
