

Relating to Assignment and Assumption Agreement dated September 24, 1996 between Barclays Bank PLC and BASF Capital Corporation

• Conditional Sale Agreement dated as of May 1, 1986 ("Conditional Sale Agreement") between Trinity Industries, Inc. ("Trinity") and Barclays Business Credit, Inc. (successor by merger to Barclays Leasing, Inc. (f/k/a Barclays American/Leasing, Inc.)) ("BBCI"), filed with the Interstate Commerce Commission on August 22, 1986 pursuant to 49 U.S.C. §11303, instrument no. 15033.

• Lease of Railroad Equipment dated as of May 1, 1986 between BASF Corporation ("BASF"), lessee, and BBCI, lessor, filed with the Interstate Commerce Commission on August 22, 1986 pursuant to 49 U.S.C. §11303, instrument no. 15033-B.

• Assignment of Lease and Agreement dated as of May 1, 1986 between BBCI and Barclays Bank PLC ("Barclays"), together with the Consent and Agreement of BASF thereto, filed with the Interstate Commerce Commission on August 22, 1986 pursuant to 49 U.S.C. §11303, instrument no. 15033-C.

• Agreement and Assignment dated as of May 1, 1986, between Trinity and Barclays together with the Acknowledgement of Notice of Assignment of BBCI thereto, filed with the Interstate Commerce Commission on August 22, 1986 pursuant to 49 U.S.C. §11303, instrument no. 15033-A.

• Participation Agreement dated as of May 1, 1986, among BASF, BBCI and Barclays.

• Amendment to Conditional Sale Agreement [BASF '86] dated as of September 24, 1996 between BBCI and Barclays.

• Amendment to Lease of Railroad Equipment dated as of September 24, 1996 between BASF and BBCI.

The foregoing instruments (each as heretofore amended) are hereinafter collectively referred to as the "1986 Documentation."


Pursuant to the Assignment and Assumption Agreement dated September 24, 1996 (the "Assignment Agreement") between Barclays and BASF Capital Corporation ("BASF Capital"), Barclays has agreed to transfer and assign to BASF Capital all right, title and interest of Barclays in, to and under the 1986 Documentation and conditional sale indebtedness in respect of the units of railroad equipment subject thereto from time to time.

Barclays hereby assigns, transfers and sets over unto BASF Capital, its successors and assigns all right, title and interest of Barclays in, to and under the 1986 Documentation and conditional sale indebtedness in respect of the units of railroad equipment subject thereto from time to time. BASF Capital hereby accepts such assignment, transfer and setting over and assumes all of Barclays' rights, benefits, and interests in, to and under, and Barclays' duties, liabilities and obligations under and in respect of, the 1986 Documentation.

This Assignment of Instruments shall evidence the assignment of the 1986 Documentation on the records of the Surface Transportation Board of the Department of Transportation. Nothing in this Assignment of Instruments shall be deemed to amend, modify or otherwise alter the provisions of the Assignment Agreement.
