



PARTIAL TERMINATION OF LEASE OCT 16 1995 -10 25 AM

INTERSTATE COMMERCE COMMISSION

This Partial Termination of Lease, dated as of September 27, 1995, by and between INDIANA MICHIGAN POWER COMPANY ("Lessee") and SHAWMUT BANK CONNECTICUT, NATIONAL ASSOCIATION, successor to The Connecticut National Bank, not in its individual capacity but solely as Owner Trustee ("Lessor").

WHEREAS, Lessee and Lessor are parties to a Railcar Lease, dated as of March 1, 1991 ("Lease"); and

WHEREAS, the Lease was duly filed for recordation with the Interstate Commerce Commission ("ICC"), pursuant to 49 U.S.C. Section 11303, on March 15, 1991 at 1:10 p.m. and given Recordation Number 17254; and

WHEREAS, Lease Supplement No. 1 was duly filed for recordation with the Interstate Commerce Commission ("ICC"), pursuant to 49 U.S.C. Section 11303, on March 15, 1991 at 1:10 p.m. and given Recordation Number 17254-B; and

WHEREAS, Lessee and Lessor desire to terminate and cancel the Lease with respect to the equipment described herein and to record such termination and cancellation with the ICC;

NOW THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt of which is acknowledged, Lessee and Lessor, intending to be legally bound, agree as follows:

1. Lessee and Lessor hereby terminate and cancel the Lease, effective September 27, 1995 with respect to the equipment described on Schedule A attached hereto (hereinafter, "Terminated Equipment").
2. The parties agree to record this Partial Termination of Lease with the ICC so as to release any lien against the Terminated Equipment created by or arising out of the Lease.
3. Nothing herein contained shall be construed to terminate and cancel the Lease with respect to any equipment other than the Terminated Equipment hereinabove specifically described.
4. This Partial Termination of Lease may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one Partial Termination of Lease.
