**PARTIAL RELEASE AND TERMINATION  
(AMTRAK TRUST 94-B)**

This Partial Release and Termination is made by EXPORT DEVELOPMENT CORPORATION ("*EDC*").

WHEREAS, EDC and NATIONAL RAILROAD PASSENGER CORPORATION ("*AMTRAK*") entered into that certain Security Agreement (Mortgage) (as the same may have been amended, modified or supplemented from time to time, the "*Mortgage*") dated as of April 19, 1991, securing certain obligations of AMTRAK to EDC, and

WHEREAS, the Mortgage was recorded with the Interstate Commerce Commission on April 19, 1991 under Recordation No. 17286, and

WHEREAS, the obligations secured by the Mortgage relating to the railroad cars described on Schedule I attached hereto and made a part hereof (collectively, the "*Railroad Cars*") has been fully satisfied and discharged;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, EDC hereby releases and terminates any and all rights, security interests, liens and other interests created by the Mortgage to the extent related to the Railroad Cars and fully releases and discharges all the Railroad Cars described therein.
