

SCHEDULE NO. 3

INTERSTATE COMMERCE COMMISSION

This Schedule No. 3 ("Schedule") to that certain Lease Agreement (the "Agreement") made as of May 2, 1990, between ITEL RAIL CORPORATION ("Lessor") and SABINE RIVER AND NORTHERN RAILROAD COMPANY ("Lessee") is made as of May 14, 1990-1991.

R E C I T A L S :

A. Lessor and Lessee are parties to the Lease Agreement dated October 14, 1984, as amended, wherein Lessor leased to Lessee <sup>19</sup> 750 > 1137 boxcars from within the series SRN 3500-6020 ("Cars"). The car bearing the reporting marks SRN 5467 was destroyed on November 21, 1988 and was removed from the Lease Agreement dated October 14, 1984.

B. The parties now desire to terminate the Lease Agreement dated October 14, 1984 and add the Cars to the Agreement and this Schedule.

Lessor and Lessee agree as follows:

- Capitalized Terms:** All capitalized terms defined in the Agreement shall have the meanings defined therein when used in this Schedule No. 3 except that the term "Cars" as used herein shall only refer to the equipment described in this Schedule unless otherwise indicated.
- Cars Leased:** Lessor hereby leases the following Cars to Lessee subject to the terms and conditions of the Agreement and this Schedule:

3. **"Expiration Date"**: Upon the full execution of the Termination Agreement dated May 14, 1991 ~~1990~~ between the parties, the Agreement and this Schedule, the initial term ("Initial Term") for each Car shall be deemed to have commenced on October 1, 1990 and shall continue through the Expiration Date of December 31, 1993.

5. **Party Responsible for Maintenance**: Lessor
6. **Average Number of Miles Per Day**: 73
7. **Party Responsible for Revenue Bill Movement, if any, to Lessee's Lines Prior to Initial Loading**: Lessor
8. **Rent**:
- A. Lessee agrees to pay the following rent to Lessor for the use of the Cars:
- (i) Lessor shall retain a sum equal to
- B. Lessee shall be entitled to the following:
- (i) With respect to the Cars described on this Schedule, effective October 1, 1990 Lessee shall be entitled to receive \_\_\_\_\_ per Car for each full Service Month that such Car is subject to the Agreement.
- (ii) The Monthly Payment shall be prorated at \_\_\_\_\_ per day for each Car that is not subject to the Agreement for an entire Service Month.
- (iii) Lessor shall pay Lessee the Monthly Payment, or prorated portion thereof, for each Car within 60 days after the close of each Service Month.

9. **Minimum Rent:**

A. **"Minimum Rent"** means the dollar amount for any calendar quarter (or applicable portion thereof) which equals the Revenues the Cars on this Schedule would have earned in the aggregate during such quarter (or applicable portion thereof) if such Cars had been on railroad lines other than Eligible Lines for \_\_\_\_\_ during such quarter, with each Car traveling \_\_\_\_\_ per day and with each Car earning Revenues at the Revenue Rates.

B. **If Revenues are Less Than Minimum Rent**

If, with respect to the Cars on this Schedule during any calendar quarter, Revenues received by Lessor for such Cars are less than the Minimum Rent for such Cars, then Lessor may so notify Lessee. Within 10 days of such notice, Lessee shall either:

- (i) Notify Lessor of intent to pay Lessor the shortfall between the Minimum Rent and the Revenues received by Lessor for such Cars in such calendar quarter and agree to pay the shortfall, if any, between the Minimum Rent and the Revenues received by Lessor for such Cars in each subsequent calendar quarter for the duration of the term. Lessee shall pay Lessor such shortfall not later than 60 days after receiving an invoice.
- (ii) Elect in writing not to pay Lessor such shortfall for such quarter. In such event, Lessor may terminate the lease with respect to all or any of the Cars on this Schedule upon not less than 30 days written notice to Lessee at any time during the Agreement.

10. **Special Terms:**

A. If the Agreement has not been terminated early, the Agreement shall automatically be extended for 4 consecutive periods of 6 months each (each such period an "Extended Term") with respect to all of the Cars described in this Agreement, provided that Lessor may terminate the Agreement effective at the end of the Initial Term or any Extended Term as to some or all of the Cars by providing not less than thirty (30) days prior written notice to Lessee.

B. The Cars are in Lessee's possession therefore this Schedule does not contain an Exhibit A.

Each party, pursuant to due corporate authority, has caused this Schedule to be executed by its authorized officer, and each of the undersigned hereto declares pursuant to 28 U.S.C. Section 1746 under penalty of perjury that the foregoing is true and correct and was executed on the date indicated below its signature.
