





**TERMINATION OF LEASE**

This Termination of Lease (this "Termination") terminates that certain Equipment Lease dated as of May 1, 1991 (the "Lease"), bearing Recordation No 17448, between The David J Joseph Company, as Lessor ("Lessor") and Waste Management of Ohio, Inc, as Lessee ("Lessee"), with respect to two (2) gondola railcars, DJJX 1-2, and six (6) railcars, DJJX 3-8, inclusive (hereinafter, the "Terminated Equipment").

WHEREAS, Lessor and Lessee executed the Lease relating to the Terminated Equipment, and

WHEREAS, Lessee has satisfied its obligations under the Lease, and all interest, including but not limited to possessory, ownership or leasehold interest, of the Lessee, its successors and assigns in the Terminated Equipment arising pursuant to the Lease has been terminated and all of Lessee's interest in the Lease and the Terminated Equipment has been transferred to Lessor, its successor in interest, and

NOW, THEREFORE, in consideration of the premises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lessor declares.

1 Lessee has satisfied, and is hereby released from, all obligations to the Lessor arising under the Lease.

2. All interest, including, but not limited to, possessory, ownership or leasehold interest, of the Lessee, its successors and assigns, in the Terminated Equipment arising pursuant to the Lease has been terminated

3 The Lessor hereby terminates and cancels the Lease

4 The Lessor shall record this Termination with the Surface Transportation Board so as to record the release of the lien against the Terminated Equipment constituted by the Lease




