

This TERMINATION AND RELEASE (AMTRAK TRUST 98-C) dated September 29, 1998 (the "*Termination Agreement*") is made by EXPORT DEVELOPMENT CORPORATION, Place Export Canada, 151 O'Connor Street, Ottawa, Canada K1A 1K3 (hereinafter "*EDC*").

WITNESSETH:

WHEREAS, National Railroad Passenger Corporation ("*Amtrak*") and EDC entered into that certain Loan Agreement, dated as of April 19, 1991 (as amended, modified or supplemented from time to time, the "*1991 Loan Agreement*"), pursuant to which EDC loaned funds to Amtrak for the purpose of acquiring those passenger rail cars identified on Annex A hereto (collectively, the "*1991 Mortgaged Rail Cars*");

WHEREAS, Amtrak and EDC entered into that certain Security Agreement (Mortgage), dated as of April 19, 1991 (as amended, modified or supplemented from time to time, the "*1991 Security Agreement*"), that was recorded with the Surface Transportation Board (f/k/a the Interstate Commerce Commission) on April 19, 1991 under Recordation No. 17286, pursuant to which Amtrak granted to EDC a security interest in the 1991 Mortgaged Rail Cars;

WHEREAS, Amtrak and EDC entered into that certain Loan Agreement, dated as of December 8, 1993 (as amended, modified or supplemented from time to time, the "*1993 Loan Agreement*"), pursuant to which EDC loaned funds to Amtrak for the purpose of acquiring those passenger rail cars identified on Annex B hereto (collectively, the "*1993 Mortgaged Rail Cars*", the 1991 Mortgaged Rail Cars and the 1993 Mortgaged Rail Cars are collectively referred to as the "*Mortgaged Rail Cars*");

WHEREAS, Amtrak and EDC entered into that certain Security Agreement (Mortgage), dated as of December 8, 1993 (as amended, modified or supplemented from time to time, the "*1993 Security Agreement*"), that was recorded with the Surface Transportation Board (f/k/a the Interstate Commerce Commission) on April 17, 1995 under Recordation No. 17286-Q, pursuant to which Amtrak granted to EDC a security interest in the 1993 Mortgaged Rail Cars;

WHEREAS, on the date hereof, First Union National Bank, a national banking association, as Owner Trustee under that certain Trust Agreement (Amtrak Trust 98-C) dated as of September 15, 1998 ("*Owner Trustee*"), has made arrangements satisfactory to Amtrak and EDC for the purchase of the Mortgaged Rail Cars;

WHEREAS, on the date hereof, Amtrak has delivered to the Owner Trustee, against receipt of the purchase price therefor, a Bill of Sale (Amtrak Trust 98-C) with respect to the Mortgaged Rail Cars.

NOW, THEREFORE, EDC agrees as follows:

Section 1. Termination and Release of the Mortgaged Rail Cars. All right, title and interest of EDC in and to the Mortgaged Rail Cars, arising from and through the 1991 Security Agreement and the 1993 Security Agreement, is hereby terminated and released.

Section 2. Further Assurances. EDC hereby agrees to execute and deliver to Owner Trustee, at Owner Trustee's cost and expense, such additional instruments, notices, or releases as Owner Trustee may reasonably request to effectuate the foregoing provisions of this Termination and Release.

Section 3. Discharge of Obligations. Amtrak has discharged all of its obligations under the 1991 Loan Agreement, the 1991 Security Agreement, the 1993 Loan Agreement and the 1993 Security Agreement (the "Agreements") and all documents entered into in connection therewith, and all the Agreements and all such other documents are hereby terminated and of no further force or effect.

Section 4. Representations and Warranties. EDC represents and warrants that this Termination Agreement constitutes the legal and valid obligation of EDC, enforceable against EDC in accordance with its terms, and EDC has full authority to terminate and release all of its right, title and interest in and to the Mortgaged Rail Cars.

IN WITNESS WHEREOF, EDC has caused this Termination and Release to be duly executed by its duly authorized representative as of the day and year first above written.


