

LEASE AGREEMENT

1. This Lease Agreement is made and entered into as of July 3, 1991, by and between RAILCAR, LTD., a Georgia corporation, acting as principal and/or agent for owners, and CHRISTIAN COUNTY LANDFILL, INC., a Delaware corporation.

2. Railcar, Ltd. agrees to lease to Christian County Landfill, Inc. and Christian County Landfill, Inc. agrees to and hereby leases from Railcar Ltd., the following:

One Hundred (100) 60 foot, 100 ton boxcars with 16 foot wide doors bearing EMAX reporting marks within the series 40000-40099.


