WHEREAS, Martin Gas Transport, Inc. has now discharged all of its indebtedness secured by the said Agreement, thus terminating the said Agreement; and


WHEREAS, it is desired by the parties to the Agreement to show for the public record the full, complete release, termination and cancellation of the aforesaid Agreement.


