KNOW ALL PERSONS BY THESE PRESENTS THAT:

WHEREAS, First Security Bank of Utah, National Association, as Owner-Trustee under Cypress Equipment Fund, Ltd. Trust No. 92-1 (Debtor) and State Street Bank and Trust Company of Connecticut, National Association, as Security-Trustee (Secured Party) entered into a Security Agreement-Trust Deed dated as of February 1, 1992, securing certain obligations of the Debtor to the Secured Party, and

WHEREAS, the aforesaid Security Agreement-Trust Deed was filed and recorded with the Interstate Commerce Commission on February 27, 1992 and has been assigned Recordation No. 17716, and

WHEREAS, a related Security Agreement-Trust Deed Supplement No. 1 dated as of February 25, 1992 was filed and recorded with the Interstate Commerce Commission on February 27, 1992 and has been assigned Recordation No. 17716-A, and

WHEREAS, the said Security Agreement-Trust Deed, as supplemented, created a lien and encumbrance against certain designated locomotives, the Collateral, and

WHEREAS, the aforesaid locomotives, among others, were the subject of that certain Master Leasing Agreement, dated as of December 1, 1983, by and between BLC Corporation (Lessor) and Southern Pacific Transportation Company (Lessee), as later amended, supplemented and assigned, recorded with the Interstate Commerce Commission December 23, 1983 under Recordation No. 14229-A, and

WHEREAS, the aforesaid locomotives were the subject of that certain Acknowledgment of Assignment and Agreement dated as of February 25, 1992, among Southern Pacific Transportation Company (Lessee), BLC Corporation (Original Lessor), First Security Bank of Utah, National Association (Assignee, that is, lessor by assignment), not in its individual capacity but solely as Owner-Trustee under Cypress Equipment Fund, Ltd. Trust No. 92-1, and State Street Bank and Trust Company of Connecticut, National Association (Secured Party), recorded with the Interstate Commerce Commission February 27, 1992 under Recordation No. 14229-T, and

WHEREAS, as to all of the aforesaid locomotives, the Collateral, the parties identified above wish to fully release the aforesaid liens and encumbrances created by and under the aforesaid Security Agreement-Trust Deed under Recordation No. 17716 and as created by and under the aforesaid Acknowledgment of Assignment and Agreement under Recordation No. 14229-T, and

WHEREAS, the obligations secured by and under the aforesaid Security Agreement-Trust Deed under Recordation No. 17716 and under the aforesaid Acknowledgment of Assignment and Agreement under Recordation No. 14229-T have been fully satisfied and discharged;

NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is acknowledged, and intending to be legally bound, the Secured Party, State Street Bank and Trust Company of Connecticut, National Association, does hereby release, terminate and discharge *in toto* the aforesaid Security Agreement-Trust Deed, as supplemented and the aforesaid Acknowledgment of Assignment and Agreement, and does fully release and discharge all the locomotives, all the Collateral, from and under the liens and encumbrances created by the said Security Agreement-Trust Deed, as supplemented and the said Acknowledgment of Assignment and Agreement.


