Also enclosed is a payment of \$16 payable to the order of the Interstate Commerce Commission covering the required recordation fee.





MEMORANDUM OF LEASE AGREEMENT

BETWEEN

GREENBRIER LEASING CORPORATION ("LESSOR")

AND

NORFOLK SOUTHERN CORPORATION ("LESSEE")

MARCH 12, 1993

Memorandum of a Lease Agreement made and entered into as of March 12, 1993 by and between Greenbrier Leasing Corporation, a Delaware corporation, ("Lessor") and Norfolk Southern Corporation, a Virginia corporation ("Lessee").

WITNESSETH:

- 1. Lessor has agreed to furnish to Lessee, and the Lessee has agreed to lease from Lessor fifty (50) 89-foot, 70-ton pipeflat railcars equipped with bearing pieces and chain tie down devices bearing marks and numbers as follows:
