



AMENDMENT TO  
RAILROAD EQUIPMENT LEASE

This Amendment to Railroad Equipment Lease (the "Amendment") is entered into this 28th day of February, 1994, by and between The David J Joseph Company, a Delaware corporation, (hereinafter referred to as "Lessor") and Chicago Southshore and South Bend Railroad, an Indiana general partnership (hereinafter referred to as "Lessee") amending the Railroad Equipment Lease (the "Lease") dated October 21, 1993, by and between Lessor and Lessee

WHEREAS, the Lease was duly filed for recordation with the Interstate Commerce Commission ("ICC") on November 15, 1993 with recordation number 18477

WHEREAS, the parties desire to amend the Lease by deleting the four (4) gondola railcars bearing reporting marks CSS 47021 - CSS 47024, inclusive and adding to the Lease, in addition to the seventy-one (71) gondola railcars bearing reporting marks CSS 47000 - CSS 47020, inclusive and CSS 47025 - CSS 47074, inclusive, which are currently subject to the Lease, fourteen (14) more gondola railcars bearing reporting marks CSS 47075 - CSS 47088, inclusive (all such railcars hereinafter collectively referred to as the "Units") The parties desire to further amend the Lease to reflect that the Lease shall end for all Units on [REDACTED] (the "Expiration Date") or the date upon which all of the Lessee's obligations under the Lease have been met (the "Termination Date") All other terms and conditions of the Lease remain unchanged and in full force and effect

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows

The Lease is amended to reflect the actual quantity of Units, which are subject to the Lease, from seventy-five (75) Units to eighty-five (85) by deleting Exhibit A to the Lease in its entirety and replacing it with Exhibit A attached hereto The Lease is further amended to reflect that the Lease shall end for all Units on the Expiration Date or on the Termination Date All other terms and conditions of the Lease remain unchanged and in full force and effect
