

TERMINATION AGREEMENT AND RELEASE APR 15 1991 -10 40 AM

WHEREAS, THE CONNECTICUT BANK AND TRUST COMPANY, INTERSTATE COMMERCE COMMISSION ASSOCIATION ("CBT") and THE MARYLAND AND PENNSYLVANIA RAILROAD COMPANY ("MPA") are parties to a Lease of Railroad Equipment ("Lease") dated as of February 25, 1987, covering forty-five (45) boxcars bearing road numbers listed on Exhibit A attached hereto and made a part hereto (the "Cars") which Lease was filed with the Interstate Commerce Commission (the "ICC") on June 25, 1987, under Recordation No. 15249-C;

WHEREAS, on December 29, 1988, the Lease was assigned to Citicorp North America, Inc.;

WHEREAS, on February 1, 1989 the Lease was further assigned to Chrysler Rail Transportation Corporation ("Chrysler") and

WHEREAS, Chrysler and MPA desire to terminate the Lease and release the lien created pursuant thereto;

NOW, THEREFORE, in consideration of the mutual covenants contained herein and for other valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree:

1. Termination. The Lease is terminated and the Cars are released from the liens, assignment and security interest created thereunder.


2. Filing. The parties consent to the filing of this Termination and Release and any other necessary documents with the Interstate Commerce Commission (and, if necessary, with any other regulatory or governmental entity) to effect a release of this lien of record existing against the Cars.




