

**AMENDMENT TO  
RAILROAD EQUIPMENT LEASE**

INTERSTATE COMMERCE COMMISSION

This Amendment to Railroad Equipment Lease (the "Amendment") is entered into this 13th day of April, 1993, by and between The David J. Joseph Company, a Delaware corporation, (hereinafter referred to as "Lessor") and Peoria and Pekin Union Railway, an Illinois corporation (hereinafter referred to as "Lessee") amending the Lease Agreement (the "Lease") dated January 8, 1988, by and between Lessor and Lessee.

WHEREAS, the parties desire to amend the Lease to extend the Lease expiration date to October 31, 1996, for all ten (10) gondola cars identified with reporting marks PPU 2020 - PPU 2029, inclusive, (the "Cars") which are the subject of the Lease.
