

THIS AGREEMENT made the 27 day of September, 1990, between THE NEW YORK, SUSQUEHANNA AND WESTERN RAILWAY CORPORATION (NYS&W), having a place of business at 1 Railroad Avenue, Cooperstown, New York 13326 (herein called the "Mortgagor"), and MOHAWK VALLEY REHABILITATION CORPORATION (MORECO), a corporation organized and existing under the laws of the State of New York, having a place of business at 26 West Main Street, Mohawk, New York 13407 (herein called the "Mortgagee").

W I T N E S S E T H :

WHEREAS, the Mortgagee is the holder of a Note dated June 21, 1982 in the face amount of \$40,000.00 executed by the Mortgagor in favor of the Mortgagee; and

WHEREAS, the Mortgagee is also the holder of a Security Agreement dated June 24, 1982 which, as security for the payment of the aforesaid Note grants to the Mortgagee a security interest to all the collateral and security described therein; and

WHEREAS Mortgagor has satisfied its obligations to Mortgagee under said Note and Security Agreement.

NOW, THEREFORE, in consideration of the mutual promises, covenants and agreements, the receipt of which is hereby acknowledged, the Mortgagor and Mortgagee mutually covenant and agree as follows:

- A. Mortgagee hereby releases the collateral security

for the repayment of the aforesaid Note.


B. The Note, Security Agreement and all other documents executed in connection therewith are hereby satisfied and discharged.




