PARTIAL TERMINATION OF LEASE

THIS PARTIAL TERMINATION OF LEASE OF RAILROAD EQUIPMENT ("Termination") is made as of October 15, 1996, by CARLAND, INC., a Delaware corporation ("Lessor").

- 1. Recitals. Lessor entered into the Lease Agreement made as of April 30, 1982 (the "Lease"), with the LOUISIANA AND ARKANSAS RAILWAY COMPANY, a Delaware corporation, with respect to locomotives, including KCS 781, KCS 789 and KCS 795, described in Schedule A attached hereto (the "Units"). The Lease is on file at the Surface Transportation Board of the Department of Transportation ("STB")(formerly known as the Interstate Commerce Commission ("ICC") under ICC recordation Number 13831 , filed on November 4, 1982.

This Lease was terminated as to the Units on January 22, 1992. The purpose of this Termination of Lease is to provide a formal termination document for filing with the STB.

- 2. Termination. The Lease as to the Units is hereby formally terminated.
