TERMINATION AND RELEASE OF LEASE

FOR VALUE RECEIVED, the undersigned, The Connecticut Bank and Trust Company, National Association, successor in interest to The Connecticut Bank and Trust Company as Owner-Trustee of the Series 1 Trust established under the Master Trust Agreement dated as of February 2, 1976 with NB5 Leasing Company, as Trustor, as supplemented, including the Supplement dated as of October 15, 1979 ("Owner-Trustee") and First Security Bank of Idaho, N.A., successor in interest to First Security State Bank, not in its individual capacity, but solely as trustee under a Lease Trust Agreement dated as of October 15, 1979 ("Lessee") hereby agree to the termination of that certain Lease of Railroad Equipment dated as of October 15, 1979 between Lessee and Owner-Trustee and filed with the Interstate Commerce Commission on November 30, 1979 under Recordation No. 11124-A and that certain Lease Agreement dated as of October 15, 1979 between Owner-Trustee and Lessee filed with the Interstate Commerce Commission on October 26, 1979 under Recordation No. 10954 (such two leases collectively, the "Lease"). Each party represents that it has not assigned its interest in or to the Lease. Lessee on behalf of itself and all of its beneficiaries, further hereby releases Owner-Trustee and any and all Owners under the Trust Agreement pursuant to which it serves as Owner-Trustee from any and all liability under the Lease and releases to Owner-Trustee all of its right, title and interest in and to all Equipment, subleases and any other assets under the Lease. Owner-Trustee, on behalf of itself and any and all Owners under the Trust Agreement pursuant to which it serves as Owner-Trustee, further hereby releases Lessee and any and all of its beneficiaries under said Lease Trust Agreement from any and all liability under the Lease, except such release shall not extend to any lessees of Lessee or any other persons claiming by or through Lessee.
