



TERMINATION OF LEASE

THIS TERMINATION OF LEASE OF RAILROAD EQUIPMENT ("Termination") is dated as of August 18, 1997 by HELM FINANCIAL CORPORATION, a California corporation ("Lessor").

1. Recitals. Lessor entered into the Lease of Railroad Equipment dated as of July 26, 1989 ("Lease") with Tradewater Railway Company, a Kentucky corporation, with respect to the twenty-four (24), 3,600 cubic foot, 100-ton capacity, roller bearing, open top, coal gondola railcars bearing the reporting mark and numbers HLMX 800-823. 
