



MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE made as of December 23, 1996 is intended to evidence the Master Equipment Operating Lease and Schedule 4 to Master Equipment Operating Lease, each dated as of December 23, 1996 (collectively, the "Lease"), between WHITMAN LEASING, INC., a Delaware corporation ("Lessor"), and ILLINOIS CENTRAL RAILROAD COMPANY, a Delaware corporation ("Lessee"), for the purpose of satisfying the requirements of recordation with the Surface Transportation Board under 49 U.S.C. § 11301. 
