

KNOW ALL MEN BY THESE PRESENTS that: Ford Motor Credit Company ("Seller"), in consideration of Ten Dollars and other good and valuable considerations, receipt of which is hereby acknowledged, does hereby transfer and assign to GATX Capital Corporation, a Delaware corporation ("Purchaser"), its successors and assigns, all of Seller's right, title and interest in and to the Trust Estate (as such term, and all other capitalized terms used herein, is defined in that certain Purchase Agreement, dated as of May 14, 1993, between Seller, Purchaser and United States Leasing International, Inc.) under: (i) that certain Trust Agreement, dated as of September 1, 1977, between Ford Motor Credit Company, as successor by merger to American Road Equity Corporation, as Trustor, and The First National Bank of Chicago, as Trustee ("Trust Estate No. 6"). The foregoing transfers and assignments shall include Prior Claims relating to Casualty Occurrences but shall exclude all other Prior Claims.

TO HAVE AND TO HOLD such beneficial interest in said Trust Estate unto Purchaser, its successors and assigns, for its and their own use forever.

SELLER hereby warrants that it has good and marketable title to a 100% beneficial ownership interest in Trust Estate No. 6; free and clear of all Liens. The Operative Documents constitute the only restrictions on transfer affecting the Trust Estate.


