



RELEASE AND TERMINATION STATEMENT dated as of December 19, 1997, by First Security Bank, N.A., as successor First Security Bank of Utah, N.A., acting as agent under the Participation Agreement referred to below (hereinafter, in such capacity, called the Secured Party)

WHEREAS the Secured Party has acted as agent for certain debt participants pursuant to the Participation Agreement (No. 1) dated as of August 1, 1977 among TTX Company (i/k/a Trailer Train Company), a Delaware corporation, the Secured Party and such debt participants;

WHEREAS First Security Bank, N.A., as successor to First Security State Bank, acting as Owner-Trustee for Michigan National Leasing Company and The Liberty National Leasing Company under the Trust Agreement (No. 1) dated as of August 1, 1977 (hereinafter, in such capacity, called the Owner-Trustee), has entered into that certain Conditional Sale Agreement (No. 1) dated as of August 1, 1977 (hereinafter called the Conditional Sale Agreement) with Bethlehem Steel Corporation and Pullman Incorporated, and supplemented by Amendment Agreement (No. 1) dated as of August 1, 1978 among the Owner-Trustee, TTX Company and the Secured Party, covering the railroad equipment listed in Schedule A hereto;


WHEREAS Bethlehem Steel Corporation and Pullman Incorporated have assigned their interest in and to said railroad equipment and the obligations of the Owner-Trustee under the Conditional Sale Agreement to the Secured Party pursuant to the Agreement and Assignment (No. 1) dated as of August 1, 1977 (hereinafter called the Agreement and Assignment); and

WHEREAS the Conditional Sale Agreement, the Agreement and Assignment, and the Amendment Agreement (No. 1) have been recorded with the Interstate Commerce Commission and assigned recordation numbers 8996, 8996-A, and 8996-H, respectively; and

WHEREAS, the obligations of the Owner-Trustee under the Conditional Sale Agreement have been paid and discharged, and the interest of the Secured Party in the railroad equipment covered thereby has been terminated.

IN WITNESS WHEREOF, the Secured Party wishes to acknowledge the termination of the Conditional Sale Agreement and to show for the public record the release of its interest in and to the railroad equipment listed in Schedule A hereto, and accordingly has caused this Release and Termination Statement to be executed by its officer thereunto duly authorized, as of the date first above written.


