

Gentlemen:


First National Bank of Fort Worth which went into receivership in July of 1988 failed to terminate its security interest in above mentioned security agreement. With this letter we are confirming that the debt has been satisfied and we are requesting that a lien release be recorded with the ICC, based on enclosed copy of the Uniform Commercial Code Financing Statement Change, which is our only proof that the First National Bank of Fort Worth no longer claims a security interest as of January 20, 1984.

The original loan was made by First National Bank of Fort Worth in December of 1977. First National Bank of Fort Worth changed its name to InterFirst Bank of Fort Worth and then went into receivership in July of 1988 and was taken over by North Carolina National Bank. At this time it is very difficult for North Carolina National Bank to find any documentation on this loan transaction.






