On behalf of CSX Transportation, Inc. ("CSXT"), enclosed for filing and recordation under 49 U.S.C. § 11303(a) and the regulations promulgated thereunder are four (4) counterparts of a Supplemental Agreement, dated as of September 30, 1992, between Mercantile-Safe Deposit and Trust Company, as Trustee under Western Maryland Railway Company Equipment Trust, dated as of March 15, 1978, and CSXT, successor by merger to Western Maryland Railway Company. 

THIS SUPPLEMENTAL AGREEMENT, dated as of September 30, 1992, by and between MERCANTILE-SAFE DEPOSIT AND TRUST COMPANY, of Baltimore, Maryland, a corporation duly organized and existing under the laws of the State of Maryland, as Trustee (the "Trustee") under the Western Maryland Railway Company Equipment Trust, dated as of March 15, 1978 (the "Equipment Trust Agreement"), and CSX TRANSPORTATION, INC. (successor to the Western Maryland Railway Company), a corporation duly organized and existing under the laws of the Commonwealth of Virginia (the "Railroad").

WITNESSETH:

WHEREAS, by the Equipment Trust Agreement, there was leased to the Railroad certain railroad equipment as more fully described in the Equipment Trust Agreement; and

WHEREAS, the Equipment Trust Agreement was, in accordance with the provisions thereof, filed and recorded with the Interstate Commerce Commission on March 29, 1978 and assigned Recordation No. 9296; and

WHEREAS, there is now on deposit with the Trustee the sum of \$443,914.90 and the Railroad has and does hereby request the Trustee to acquire with such funds so on deposit and deliver to it under the Equipment Trust Agreement four 3,000 H.P. EMD Model GP40-2 diesel-electric locomotives bearing the Railroad's road numbers 6045/6046 and 6048/6049. ✓

NOW, THEREFORE, the Railroad does hereby agree to sell, assign, transfer and set over unto the Trustee, subject to the terms of the Equipment Trust Agreement, four 3,000 H.P. EMD Model

GP40-2 diesel-electric locomotives bearing the Railroad's road numbers 6045/6046 and 6048/6049, having a unit Fair Value of \$145,892.80 and \$145,745.60 and an aggregate Fair Value as of the date hereof of \$583,276.80.

The Equipment Trust Agreement is hereby amended to include said additional equipment as Trust Equipment under the terms of the Equipment Trust Agreement.

The Trustee does hereby agree to lease said equipment to the Railroad under and subject to the terms of the Equipment Trust Agreement.

The Railroad agrees to accept and hold said equipment under and subject to the terms of the Equipment Trust Agreement, and to be bound by and to perform, with respect to said equipment, all of the applicable covenants of said Equipment Trust Agreement.

The Railroad agrees to furnish, or waive the payment of, any additional funds which may be required for the Trustee to acquire the additional equipment described herein from the funds now on deposit.


The Railroad will cause this Supplemental Agreement to be filed and recorded with the Interstate Commerce Commission pursuant to 49 U.S.C. Section 11303, and will furnish to the Trustee certificates or other evidence satisfactory to the Trustee of such filing and recording.


This Supplemental Agreement may be simultaneously executed in two or more counterparts, each of which so executed shall be deemed to be an original, and such counterparts together shall constitute

but one and the same instrument, which shall be sufficiently evidenced by any such original counterpart.
