

**KNOW ALL MEN BY THESE PRESENTS** that Mercantile-Safe Deposit and Trust Company, Trustee, under a certain Equipment Trust Agreement dated as of March 15, 1978 between Mercantile-Safe Deposit and Trust Company, Trustee, and The Western Maryland Railway Company, said Agreement establishing Western Maryland Railway Equipment Trust of 1978, hereby certifies that all of the \$9,975,000.00 principal amount of 8 1/2% Equipment Trust certificates and dividend warrants appertaining thereto issued under said Equipment Trust, have been fully paid or payment duly provided for, and all of the obligations under said Equipment Trust, have been fully complied with and performed.

**WHEREFORE**, in consideration of One Dollar (\$1.00) and other valuable consideration:

Mercantile-Safe Deposit and Trust Company does hereby declare said Equipment Trust Agreement dated as of March 15, 1978 to be satisfied and canceled and does consent that the same be discharged of record, and further Mercantile-Safe Deposit and Trust Company does hereby sell, assign, convey, transfer, set over, release and quitclaim without warranty or guaranty of any kind, express or implied, unto CSX Transportation, Inc. (Successor by merger to the Western Maryland Railway Company) all of its rights, title, and interest in and to all of the railroad equipment of every character included in the Equipment Trust Agreement dated as of March 15, 1978 and now held by Mercantile-Safe Deposit and Trust Company.

**IN WITNESS WHEREOF**, Mercantile-Safe Deposit and Trust Company has caused these presents to be executed in its name by one of its Vice President thereunto duly authorized and its corporate seal to be hereunto affixed and attested by one of its Corporate Trust Officer as of this 15th day of MARCH, 1993.
