



DISCHARGE OF SECURITY AGREEMENT

This Discharge of Security Agreement is made this 10/24 day of June, 1992 by and between Security Pacific Business Credit Inc., a Delaware Corporation ("Security Pacific") and AMG Resources Corporation, a Delaware Corporation ("AMG").

WHEREAS, as of March 4, 1988 AMG executed and delivered to Security Pacific a certain Security Agreement (Equipment Mortgage) covering railroad cars, locomotives, other rolling stock and other collateral which Security Agreement was recorded on March 7, 1988 in the Office of the Secretary of the Interstate Commerce Commission as instrument number 15521 (the "Security Agreement").

WHEREAS, AMG is no longer indebted to Security Pacific and Security Pacific desires to remove any lien it may have on the railroad cars, locomotives, other rolling stock and other collateral owned by AMG.

NOW, therefore, Security Pacific and AMG agree as follows:

1. Any and all liens that Security Pacific has on the railroad cars, locomotives, other rolling stock and other collateral of AMG be and hereby are released, discharged, removed and cancelled.
2. The Security Agreement is terminated and discharges as of the date hereof.
3. This Office of the Secretary of the Interstate Commerce Commission is authorized to mark as satisfied the Security Agreement filed in its office as aforesaid.
4. If any further instruments are necessary to carry out the purposes of this Discharge of Security Agreement, the parties will execute them.


