RELEASE OF RAILROAD CAR LEASE AGREEMENT

WHEREAS, on the 1st day of November, 1988, ITG, INC., a Texas corporation, entered into a railroad car lease agreement with Iowa Interstate Railroad Company. ITG, INC. (Lessor) leased to Iowa Interstate Railroad Company (Lessee) 25 covered coil gondola railway cars more particularly described on the Exhibit A which is attached hereto as evidenced by Security Agreement bearing such date and being recorded with the Interstate Commerce Commission under Recordation No. 16149-A.

NOW, THEREFORE, Iowa Interstate Railway (Lessee) has returned 25 covered coil gondolas railway cars to ITG, INC. (Lessor) and both Lessee and Lessor have agreed to terminate the railroad car lease agreement (No. ITG-1672) and declares such railroad car lease agreement to be of no further force and effect.


