

INTERSTATE COMMERCE COMMISSION

The undersigned, Senstar Capital Corporation, a Delaware corporation formerly known as Joy Finance Company, having its principal place of business at 301 Grant Street, Pittsburgh, Pennsylvania 15219 ("Secured Party") does hereby grant to Wynchester Mining Company, a West Virginia corporation having its principal place of business at P.O. Box 568, Madison, West Virginia 25130 ("Debtor"), a full and unconditional release from any and all of the terms and conditions of that certain Security Agreement - Equipment, dated as of July 16, 1991, by and between Joy Finance Company and Debtor (the "Security Agreement"). By this Release, the Secured Party does hereby terminate its security interest in certain collateral described herein below, granted under the Security Agreement.

The Security Agreement was recorded with the Interstate Commerce Commission on July 29, 1991, and was assigned Recordation Numbers 17459 and 17460.

The Security Agreement granted the Secured Party a security interest in:
