MEMORANDUM OF SECURITY AGREEMENT
(RBBX 2001)

SURFACE TRANSPORTATION BOARD

Memorandum of Security Agreement, made and entered into as of September 17, 2001, by and between Feld Entertainment, Inc., a Delaware corporation with its principal place of business in Vienna, Virginia (the "Debtor"), and Kenneth J. Feld, a resident of Virginia (the "Subordinated Secured Party").

WITNESSETH
