**COLLATERAL RELEASE AND SUBSTITUTION
TO
SECURITY AGREEMENT**

COLLATERAL RELEASE AND SUBSTITUTION TO SECURITY AGREEMENT dated as of February 13, 2002 between UNION PACIFIC RAILROAD COMPANY ("UPRR") and J.P. MORGAN LEASING INC. ("JPMLI"), formerly known as CHASE EQUIPMENT LEASING, INC., amending the Security Agreement dated as of December 11, 1998 between UPRR and JPMLI, recorded with the Surface Transportation Board on January 4, 1999 (Surface Transportation Board Recordation Number 21933), as amended by the Collateral Release and Substitution to Security Agreement dated as of January 11, 2001 (Surface Transportation Board recordation Number 21933-A) (the "Security Agreement").

WITNESSETH:

WHEREAS, the Security Agreement provides that the Equipment in which the UPRR has granted to JPMLI a security interest shall include the Items of Equipment identified in Schedule A annexed to the Security Agreement and such additional Items of Equipment as are identified in any amendments to such schedule; and

WHEREAS, UPRR has furnished a description of Items of Equipment to be released and substituted under the Security Agreement; the railcars on Schedule A attached hereto described as "Original Car" are being released, and the railcars on Schedule A attached hereto described as "Substitute Car" are being substituted under the Security Agreement;

NOW, THEREFORE, in consideration of the mutual covenants and promises set forth in the Security Agreement and for other good and valuable consideration, it is agreed;

SECTION ONE: Schedule A to the Security Agreement is hereby amended by removing the railcars listed on Schedule A attached hereto described as "Original Car" and adding the railcars listed on Schedule A attached hereto described as "Substitute Car."

SECTION TWO: Capitalized terms which are not defined herein shall have the meanings set forth in the Security Agreement.




