**MEMORANDUM OF RELEASE AND TERMINATION OF CERTAIN EQUIPMENT
SCHEDULES AND SECURITY INTERESTS RELATED THERETO**

Memorandum of Release and Termination of Certain Equipment Schedules and Security Interests Related Thereto, made and entered into as of July 29, 2002 (this "Memorandum") by and between Fleet Capital Corporation, a Rhode Island corporation ("Lessor"), with its principal place of business at One Financial Plaza, Providence, Rhode Island 02903, and Merco Joint Venture, LLC, a New York limited liability company (the "Lessee"), having a principal place of business at c/o Eagle Land Management, Inc., 1265 Drummer Lane, Suite 102, Three Glenhardie Corporate Center, Wayne, Pennsylvania 19087.

WHEREAS, BancBoston Leasing Inc. ("BancBoston") and the Lessee entered into, among other things, (i) a certain Master Lease Agreement dated as of October 2, 1998 (the "Master Lease"), (ii) a certain Equipment Schedule No. 1 To Master Lease Agreement Dated As of October 2, 1998 ("Schedule No. 1"), (iii) a certain Equipment Schedule No. 2 To Master Lease Agreement Dated As of October 2, 1998 ("Schedule No. 2"), (iv) a certain Equipment Schedule No. 3 To Master Lease Agreement Dated As of October 2, 1998 ("Schedule No. 3"), (v) a certain Equipment Schedule No. 4 To Master Lease Agreement Dated As of October 2, 1998 ("Schedule No. 4"), (vi) a certain Equipment Schedule No. 5 To Master Lease Agreement Dated As of October 2, 1998 ("Schedule No. 5"), and (vii) a certain Equipment Schedule No. 6 To Master Lease Agreement Dated As of October 2, 1998 ("Schedule No. 6"); and

WHEREAS, BancBoston, as lessor, and the Lessee, as lessee, entered into a certain Memorandum of Lease Agreement dated as of October 2, 1998 (the "1998 Memorandum") concerning all of the equipment leased under the Master Lease, Schedule No. 1, Schedule No. 2, Schedule No. 3, Schedule No. 4, Schedule No. 5, and Schedule No. 6, which 1998 Memorandum was filed with the Surface Transportation Board (the "Board") on October 15, 1998 under Recordation Number 21715; and

WHEREAS, BancBoston sold all of BancBoston's right, title and interest in and to only Schedule No. 1 (said Schedule No. 1 and any lease documents relating only to said Schedule No. 1 hereinafter collectively referred to as the "Bombardier Lease Documents"), and only the equipment leased thereunder (collectively, the "Bombardier Leased Equipment"), to Bombardier Capital Inc. ("Bombardier") pursuant to a certain Purchase, Assignment, Assumption & Indemnity Agreement dated as of December 30, 1998 between BancBoston and Bombardier; and

WHEREAS, BancBoston, as assignor, and Bombardier, as assignee, entered into a certain Memorandum of Assignment and Assumption Agreement dated as of December 29, 1998 (the "Assignment Memorandum") concerning all of the Bombardier Leased






