
The equipment covered by the instant Full Termination is all the equipment in the Lease.

THIS MEMORANDUM OF FULL TERMINATION OF RAILROAD CAR LEASE AGREEMENT is made as of this 31st day of October, 2003 by Chicago Freight Car Leasing Company, Lessor in the aforesaid lease.

WHEREAS, Chicago Freight Car Leasing Company did lease to The Pittsburg & Shawmet Railroad Company ("Lessee") one hundred twenty-five (125) all steel, 50 ton, twin hopper cars; and

WHEREAS, the aforesaid lease dated July 31, 1963, was recorded with the then Interstate Commerce Commission (now Surface Transportation Board) on August 12, 1963 under Recordation No. 2605; and

WHEREAS, the term of the aforesaid lease has ended, has not been extended, and all duties, obligations and payments under the said lease have been fulfilled and the units of rolling stock under the lease are no longer in possession of the Lessee;

NOW, THEREFORE, this Memorandum of Full Termination of Railroad Car Lease Agreement is recorded for the purpose of officially fully terminating of record in the files of the Surface Transportation Board the aforesaid lease.
