MEMORANDUM OF SECURITY AGREEMENT – TRUST DEED dated as of March 3, 2004, between CANADIAN PACIFIC RAILWAY COMPANY (the “Debtor”), and WELLS FARGO BANK NORTHWEST, NATIONAL ASSOCIATION, as collateral agent (in such capacity, the “Collateral Agent”) for the Note Holders.

WHEREAS, the Debtor and the Collateral Agent are entering into that certain Security Agreement – Trust Deed to be dated as of March 3, 2004, pursuant to which, among other things, Debtor creates in, and grants to the Collateral Agent (for the benefit of itself and the Note Holders (as defined therein)) and its successors in trust, a security interest in all of the Debtor’s right, title and interest, whether now owned or hereafter acquired or arising, in and to: (i) the eighty-one (81) GE AC4400 diesel locomotives (hereinafter referred to as the “Equipment”), described more fully and identified by the reporting marks and numbers listed on Schedule A hereto together with all bills of sale, invoices and purchase orders in respect thereof, all manufacturers’ or suppliers’ warranties in respect thereof (but specifically excluding any rebates, incentive locomotives or other purchase inducements and other right under any service agreements), accessories, equipment, parts and appurtenances appertaining or attached to the Equipment, whether now owned or hereafter acquired, and all substitutions, renewals or replacements of, and additions, improvements, accessions and accumulations to the Equipment, together with all the rents, issues, income, profits, proceeds and avails therefrom and the proceeds thereof and all accessions, attachments, enhancements, accessories, additions, improvements or replacements thereto; (ii) all right, title, interest, claims and demands of the Debtor as lessee in, to and under the Lease of Locomotives to be dated as of March 3, 2004 (hereinafter referred to as the “Lease”) between Debtor and CPR Leasing Ltd., including all extensions of the term of the Lease, together with all rights, powers, privileges, options and other benefits of the Debtor as lessee under the Lease; and (iii) all right, title, interest, claims and demands of the Debtor in, to and under the other documents relating to the foregoing, including the Equipment Documents (as defined therein).

IN WITNESS WHEREOF, the parties wish to show for the public record the security interest in such Equipment that is now owned or hereafter acquired by Debtor, in favour of the Collateral Agent for the benefit of itself and the Note Holders. 
