THIS MEMORANDUM OF RAILCAR LEASE dated as of this 14th day of March, 2004, is made by THE CIT GROUP/EQUIPMENT FINANCING, INC., a Delaware corporation, with an address at 1211 Avenue of the Americas, New York, New York 10036 (the "Lessor"), and DTE TRANSPORTATION SERVICES, INC., a Michigan corporation, with an address at 350 Indiana Street, Suite 600, Golden, CO 80401 (the "Lessee" and, together with the Lessor, the "Parties").

KNOW ALL PERSONS BY THESE PRESENTS THAT:

WHEREAS, the Lessor and the Lessee entered into that certain Master Railcar Lease (the "Lease") dated as of November 3, 2000 covering certain equipment described therein and with respect to which a Memorandum of Railcar Lease was filed with the Surface Transportation Board on December 22, 2000 as Recordation Number 23276.
