MEMORANDUM OF LEASE

SURFACE TRANSPORTATION BOARD

Memorandum of Lease, made and entered into as of February 10, 2006 between **THE KANSAS CITY SOUTHERN RAILWAY COMPANY** (the "Lessee") and **PLM FINANCIAL SERVICES, INC.** (the "Lessor" and, together with the Lessee, the "Parties"). Terms used in this instrument have the meanings assigned thereto in the Equipment Lease Agreement dated as of December 23, 2005 (the "**Lease Agreement**") between the Lessee and the Lessor.

WITNESSETH:

WHEREAS, the Lessor and the Lessee entered into the Lease Agreement covering the equipment listed on Exhibit A hereto (the "Locomotives");






